Report on the scrapping of a vehicle

Please note the following before filling in the form:

If the vehicle has been scrapped at an official take-back point of Finnish Car Recycling Ltd (Suomen Autokierrätys Oy), please contact the party in charge of scrapping the vehicle to update register information. If you are not the owner of the vehicle, attach a power of attorney to the Report on the scrapping of a vehicle.

Final deregistration of a vehicle

A vehicle may be permanently removed from the register, i.e. deregistered, if the vehicle no longer exists. A vehicle that has been permanently removed from the register must have had its body or chassis scrapped or destroyed so that it can no longer be repaired or restored. A vehicle that has been permanently removed from the register cannot be re-registered, restored or approved for use on the road. A vehicle cannot be permanently removed from the register if its chassis has not been destroyed.

An application for final deregistration may be submitted by the vehicle owner. If you are acting under authorisation from another party, attach the power of attorney to your application.

The information submitted to the register must correspond to the actual circumstances. The person submitting the notification is responsible for the accuracy of the information provided.

If you cannot provide evidence that the vehicle has been scrapped but the vehicle has been transferred to another party:

Submit a notification of transfer through Traficom's e-services, at an inspection station that offers registration services or through your insurance company. Please note that if the transferee you have notified denies having purchased the vehicle, you must be able to prove that ownership has been transferred to the transferee, for example with a deed of transfer or bill of sales signed by both parties.

If you do not know to whom the vehicle was sold or given, and you cannot obtain the buyer's details for a notification of transfer:

Submit a notification of transfer of the vehicle to an unknown party through Traficom's e-services or at an inspection station that offers registration services. A fee will be charged for the notification in accordance with the decree on fees for transport-related services. The inspection station will forward your notification to Traficom for processing. If your notification is accepted, the date of transfer entered in the Transport Register will be the date on which the notification was submitted, not the actual date of transfer.

If the vehicle has been abandoned or left behind:

You may contact the authority of the municipality in question to enquire about what has happened or will happen to the vehicle. To stop charges from accumulating, you can decommission the vehicle (i.e. register it as off the road). Decommissioning is a registration notification that you can submit through Traficom's e-services, at an inspection station that offers registration services or through your insurance company. The notification is subject to a fee.

If the vehicle has been taken into the possession of the municipality:

Clarify the decommissioning of the vehicle with the municipality. The municipality may remove the vehicle from the Transport Register retroactively.

If the vehicle has been stolen:

File a police report. Vehicle tax is not charged for the period during which the vehicle is marked as stolen in the Transport Register. To ensure that vehicle tax is not debited after the entry on vehicle theft is removed, decommission the vehicle

If the vehicle has not been scrapped and you wish to end the motor liability insurance of the decommissioned vehicle:

Contact your insurance company.
