

The RVSM Airworthiness Approval is based on ICAO DOC 9574 (Manual on Implementation of a 300 m / 1 000 ft Vertical Separation Minimum Between FL 290 and FL 410 Inclusive) where, JAA LEAFLET NO 6 rev.1 (GUIDANCE MATERIAL ON THE APPROVAL OF AIRCRAFT AND OPERATORS FOR FLIGHT IN AIRSPACE ABOVE FLIGHT LEVEL 290 WHERE A 300M / 1,000 FT VERTICAL SEPARATION MINIMUM IS APPLIED), is referenced as acceptable means for the RVSM approval.
