Instructions for filling in the application

- Application** A separate application must be filled in for each ship to be mortgaged.
- Applicant** A ship mortgage may be applied for by the owner of the ship or a party with claims on same (creditor).
- Agent** The applicant may act through an agent. The agent must present a valid authorisation given by the applicant. A general power of attorney is sufficient.
- Privilege** If the mortgage application is based on several bonds, their privilege order must be entered in the application. If the privilege order is to be something other than equal privilege or numbered order, this must be indicated by giving the bonds unique identifiers and listing them in a separate enclosure if necessary.
- Date and signature**
The applicant or agent must date and sign the application.
- Enclosures** The original bond(s) must be enclosed with the application. If the applicant is a limited liability company or registered association, the ship mortgage application must include minutes of the relevant meeting of its authorised administrative body.
- Abstract of title** The applicant must state when applying for the mortgage whether an abstract of title on the ship to be mortgaged is required.
