The Finnish Transport and Communications Agency issues an Endorsement to a person who has obtained a valid GMDSS certificate and has provided evidence to meet the standard of competence according to the STCW Convention

Requirement for gaining an Endorsement for GOC or ROC certificate issued by a foreign administration:

- Only section 1 of the application form is to be filled and a copy of a valid GOC or ROC issued by a foreign administration must be enclosed to the application (no seagoing service or use of GMDSS radio equipment is needed).
If the applicant is not a Finnish citizen, a copy of the applicant's passport must be enclosed to the application.

Requirements for gaining an Endorsement for a Finnish GOC or ROC certificate:

- Sufficient use of GMDSS radio equipment equivalent to his/her radio operator's certificate and at least 360 days seagoing service during the last five years or at least 90 days seagoing service during the immediate preceding six months

NOTE1! Seagoing service may be replaced by deck officer's STCW certificate. In this case the validity period of the applied Endorsement will be the same as deck officer's certificate.

NOTE2! In case the Finnish Transport and Communications Agency has no record of sea going service of the applicant (for example service on board a foreign vessel) he/she must provide a record of the seagoing service issued by the flag state administration or the shipping company.

or

- Qualified refreshment course approved by Finnish authorities. In this case the course certificate must be enclosed to the application and no seagoing service or use of radio equipment is needed.

or

- Qualified Endorsement degree carried out in Finland

HOW TO FILL IN THE APPLICATION FORM IN CASE OF FINNISH GOC OR ROC:

If the application is based on seagoing service and use of GMDSS radio equipment the application form must contain at least eight different radio communication occurrences corresponding with the applicant's certificate.

The minimum requirement for radio communication with another station:

- GOC operators: at least four DSC communication records with an identified other station. At least two of these must be done with MF/HF/DSC equipment
- ROC operators: at least four VHF/DSC communication records with an identified other station.

In addition to the above, other use may concern other mandatory GMDSS equipment (such as testing EPIRB or SART equipment).

The entries in section 2 must be made according to the radio log of the vessel.

- Every row must have one entry regarding the use of one GMDSS equipment
- The other station must be identified with ship's name and call sign or MMSI number (if not EPIRB/SART test onboard)
- The equipment must be identified by ticking the relevant box
- Ship's Master or Chief Officer must verify the records by his signature and name in block letters.
