## Instructions

Use this application form only if you have a Finnish amateur radio certificate or a HAREC certificate granted abroad. All other applicants may use the form "Application for temporary amateur radio station licence".

- 2) Number and class of the certificate. A copy of the HAREC certificate shall be attached to the application.
- 3) To be filled in only in case of renewal or amendment of the licence.
- 4) To be filled in only if the station is situated on the Åland Islands.

### Automatic renewal of radio licences:

The validity time of a radio licence for radio transmitters is stated in the licence. As of the beginning of 2006 most radio licences will be renewed and sent to the licensee automatically without a separate application. However, the licensee may withdraw the licence with a written information to the TRAFICOM.
